### TENTATIVE PUBLIC WORKS AND SERVICES ADVERTISEMENT SCHEDULE

#### **MARCH 2023**

**Design Package #1 - E St Bernard Hwy & Utilities**: This design package includes the new road alignment for E. St. Bernard Hwy, a temporary bypass road, various street connections, earthwork, drainage, and relocation of the various Utilities along E. St. Bernard Hwy.

**Design Package #2 – Rail (Offsite):** This design package will include the relocation of the Chalmette Branch rail, offsite terminal leads & wye, terminal support yard rail tracks, earthwork and area drainage.

Advertise: March 31, 2023 Proposal Due: May 1, 2023

**Design Package #3 - Drainage, Earthwork & Surcharge**: This design package will include the site wide drainage, earthwork and surcharge. This will include some design for Violet Square drainage, stormwater conveyance ditches, isolation berm & canal, culverts not included in other design packages, SWPPP, temporary access roads, rough site grading, drainage layer, wick drains, surge and rollover phasing.

Design Package #4 - Drainage Pump Station: This design package will include the design of a new

pump station (current estimate is 300-cfs), inlet/outlet structures, foundation, and civil site design. This pump station will be designed to be expandable to 600-cfs in the future.
